ORDER

THE COURT ORDERS THAT:

- 1. Gobel Aviation Pty Ltd (**Soar**) is joined as the second defendant in the proceeding.
- 2. By 4:00pm on 31 July 2020, the plaintiffs shall amend the writ accordingly and shall file and serve an amended statement of claim against Soar as the second defendant in the proceeding.
- 3. By 4:00pm on 31 August 2020, the defendants shall each file and serve their amended defence or defence and any counterclaim to each of the amended statement of claim and the third party statement of claim.
- 4. By 4:00pm on 21 September 2020:
 - (a) the plaintiffs shall file and serve any reply to Soar's defence; and
 - (b) the first defendant shall file and serve any reply to Soar's third party defence and its defence to Soar's counterclaim (if any).

- 5. By 15 August 2020, the defendants shall each make file and serve an affidavit verifying an exhibited list in electronic form, containing the name, student reference number, address, email address and phone number, for each of its students who is a group member as defined in paragraph 1 of the plaintiff's statement of claim (as amended).
- 6. By no later than 4:00pm on 15 August 2020, each of the parties shall agree on a protocol for discovery and inspection:
 - (a) where documents will be provided electronically;
 - (b) where an electronic index of documents will be provided; and
 - (c) in accordance with Practice Note SC Gen 5 (Technology in Civil Litigation).
- 7. Paragraph 9 of the orders of the Honourable Justice John Dixon made 25 May 2020 is vacated and, in lieu thereof, by 4:00pm on 21 August 2020, the first defendant shall make discovery, by affidavit, of the categories of documents set out in annexure A to this order.
- 8. By 4:00pm on 4 September 2020, the plaintiffs and the first defendant will produce their discovery for inspection in accordance with the agreed protocol.
- 9. By 4:00pm on 30 September 2020, the parties shall confer to settle the categories of documents to be discovered by Soar in the proceeding, and by each of the plaintiff and the first defendant in respect of the claims between them and Soar.
- 10. In default of agreement being reached in regard to the matters raised in paragraphs 6 and/or 9, the parties shall attend a conference before Judicial Registrar Clayton, on a date to be nominated by the Judicial Registrar, to facilitate discussion between the parties concerning the categories of documents to be discovered, and agreement on an appropriate document management system and protocol to be used for the discovery and inspection process, and to make any necessary orders.
- 11. By 4:00pm on 6 November 2020:
 - (a) Soar shall make discovery, by affidavit; and
 - (b) the plaintiffs and the first defendant shall make any further discovery, by affidavit.
- 12. By 4:00pm on 25 September 2020, the parties are to confer for the purposes of settling the content of the opt out notice and the time by and manner in which the opt out notice is to be given to group members. In the event of agreement, the parties shall submit proposed minutes of consent orders to the court.

- 13. In default of agreement being reached in regard to the matters raised in paragraph 12, the parties shall attend a conference before Judicial Registrar Clayton, on a date to be nominated by the Judicial Registrar, to facilitate discussion between the parties concerning the content of the opt out notice, and to make any necessary orders including as to the time by and manner in which the opt out notice is to be given to group members.
- 14. 4:00pm on 18 November 2020 is fixed as the time and date before which a group member may opt out of the proceeding.
- 15. On or before 4:00pm on 15 November 2020, the plaintiff shall serve on the defendants a copy of its letter of instructions to, and a statement of the qualifications and experience of, each expert witness that it proposes to call at the trial.
- 16. On or before 4:00 pm on 11 December 2020, the plaintiffs shall file and serve any notice pursuant to order 44 of the *Supreme Court (General Civil Procedure) Rules* 2015 (**Rules**) in respect of expert evidence on which it intends to rely at trial.
- 17. On or before 4:00pm on 28 February 2021, the defendants shall file and serve any order 44 notice pursuant to the Rules in respect of expert evidence on which they intend to rely at trial.
- 18. The proceeding is referred to Efthim AsJ, or to such other judicial mediator as he may nominate, for mediation.
- 19. The parties shall endeavour to complete mediation prior to 12 March 2021.
- 20. The case management conference is adjourned for further hearing on 12 March 2021.
