Settlement Application, Set Aside Application, and Section 33K Application or in respect of any Common Fund Orders, commissions or other payments, be extended to 4.00pm on 5 June 2026.

5. The date in paragraph 43 of the orders made on 31 October 2025, by which the applicants are to file and serve any further affidavit material and outline of submissions in reply, be extended to 12.00pm on 12 June 2026.
6. The date in paragraph 43 of the orders made on 31 October 2025, by which the Funder is to file and serve any further affidavit material and outline of submissions in reply, be extended to 4.00pm on 15 June 2026.
7. The date in paragraph 50 of the orders made on 31 October 2025, by which the Contradictor is, in the event either party opposes the Court's adoption of the Report of the Costs Referee, to file and serve any submissions and affidavit material upon which it intends to rely in response to the opposition to the adoption of the Report, be extended to 4.00pm on 5 June 2026.
8. The date in paragraph 51 of the orders made on 31 October 2025, by which the applicants are to file and serve any further affidavit material and outline of submissions in reply in relation to the Report of the Costs Referee, be extended to 12.00pm on 12 June 2026.
